Time and Place for Filing Sealed Proposals. On behalf of the Broadlawns Board of Trustees, sealed proposals for all labor, materials, and equipment for the Bid Packages outlined below will be received by the Construction Manager – Graham Construction at Broadlawns Medical Center (the “Hospital”), Building One, Jenner Conference Room, 1761 Hickman Road, Des Moines, IA on the 24th day of September 2026 from 1:00 PM to 2:00 PM. Bids received after 2:00 PM will not be considered and will be returned to the bidder unopened.

Time and Place Sealed Proposals Will be Opened and Considered. Sealed proposals will be opened at 2:05 PM on the 24th day of September at the Hospital, Building One, Jenner Conference Room, 1761 Hickman Road, Des Moines, IA. . The Broadlawns Board of Trustees has delegated to the Broadlawns Chief Financial Officer the duty of receiving and opening bids, The CFO shall report the results of the bidding with the CFO’s recommendations to the Board of Trustees at its next regularly scheduled meeting or at a special meeting called for such purpose.

DESCRIPTION: Furnish all labor, material and equipment required to accomplish the construction described in the specifications, indicated on the plans, and in accordance with the schedule. The project consists of the construction of an approximately 128,300 square foot parking lot expansion with 234 new parking stalls. The work includes, but is not limited to, excavation and grading, storm drainage structures and piping, underground detention system, concrete paving, joint sealants, pavement striping, signage, retaining wall, landscaping, erosion control, a storm water retention pond and site lighting and electrical.

BID SECURITY: Each Bidder shall accompany with its bid a bid security as defined in Iowa Code section 26.8 payable to Broadlawns Medical Center in an amount equal to at least 5%. The bid security may be in the form of a Certified Check, Cashier's Check drawn on an FDIC insured bank in Iowa or on an FDIC insured bank chartered under the laws of the United States, or a certified share draft drawn on a credit union in Iowa or chartered under the laws of the United States, or a bid bond executed by corporations authorized to contract as surety in the State of Iowa. The bid bond shall be executed by the Bidder on AIA Bond Document. Bid Security shall be in a separate envelope with the sealed bid and shall be forfeited to the Owner as liquidated damages in the event the bidder fails to enter into a contract and furnish a bond within ten days after his bid has been accepted. No Bidder may withdraw its bid for at least sixty (60) days after the scheduled closing time for the receipt of bids..

The successful Bidder will be required to furnish and pay for satisfactory Performance Bond and Labor and Material Payment Bond in the amount of 100% of the Contract Price. Bond to be issued by a responsible surety approved by the Board of Trustees of Broadlawns Medical Center.

The Notice to Proceed will be issued following acceptance of the executed Contract by the successful Bidder and the requisite Performance Bond and Labor and Material Payment Bond and insurance certificates, and a determination by the OWNER that it has secured permanent financing for the Project. All work for this package shall be completed within the given schedule.

QUALIFICATIONS: Broadlawns Medical Center reserves the right to request qualification forms before issuing documents or before Contract is awarded, and to further reject any or all proposals or to waive technicalities or irregularities.. By virtue of statutory authority, a preference shall be given to products and provisions grown and produced within the State of Iowa and to Iowa domestic labor.
