HISTORY OF CHALLENGES

In 2006, Broadlawns had 15 days of cash, aged facilities and a history of financial losses. The hospital was operating at the maximum tax levy and was in jeopardy of closing. Since that time, a multi-faceted transformation has taken place.

REDEFINED CULTURE

Culture of medical excellence, compassion and collaboration

EFFICIENT OPERATIONS

- Since 2006, Broadlawns streamlined operations and reduced its cost per patient day (CPPD) by 40%.
- Broadlawns FY20 CPPD: \$1,466
- Iowa Statewide FY20 CPPD: \$2,124
- Broadlawns CPPD is 30.9% below the statewide average.
- If Broadlawns operated at the statewide CPPD, the Medicaid/ Medicare loss would be \$57,956,199.
- Operated 21.3% below property tax levy in FY20.
- Lowest cost structure in the state of lowa.

PATIENT DAYS

- ↑ Patient volumes more than quadrupled from 30K to 135K.
- ↑ Safety net patient volumes more than doubled from 25K to 64K.
- Commercially insured and Medicare patient volumes grew from 5K to 64K.

ENHANCED FACILITIES

- \$131M reinvested in Emergency, Urgent Care, Radiology, Surgery, Mental Health, Dental, Oncology, Med-Surg, Birthing Center, and ICU with no increase to the property tax levy, bond funding, or debt.
- Current capital projects include Lab and Surgery expansion.

MENTAL HEALTH

- Broadlawns is the leading mental healthcare provider in Central lowa with an experienced medical staff of 11 psychiatrists, 15 midlevel providers, 5 psychologists and 20 master's level therapists, case workers and nurses.
- New inpatient and outpatient mental health facilities were constructed from 2015-2018, representing \$15,784,902 in capital improvements.
- Inpatient beds increased to 44 beds, 147% increase. Of the 125 beds in Central Iowa, Broadlawns has 35.2% of them.
- Assumed responsibility for Mobile Crisis, Crisis Stabilization and Crisis Observation Center in August 2016.
- Opened first Psych Urgent Care Clinic in Iowa in June 2018.

Crisis services were previously administered for Polk County at a cost of \$3.5M annually through Eyerly Ball.

DIVERSITY

- 40+ different languages spoken at Broadlawns each week.
- Interpreters on staff, and 24/7 access to over 200 languages through language lines.

MEDICAL EDUCATION

- Established in 1971, Broadlawns Family Medicine Residency program was one of the first fully-accredited programs in the Midwest.
- Residents practicing in rural lowa communities with less than 30k residents: 88
- Residents practicing in Iowa: 166
- 7 of 8 Broadlawns residents in 2021 are planning to practice in rural lowa. 5 of 8 will practice obstetrics.
- Established in July 2018, the Broadlawns UnityPoint Psychiatry Residency is jointly administered with a \$3M per year investment.
- Broadlawns is establishing a one-year obstetrics fellowship program.

WORKFORCE DEVELOPMENT

- TEACH/TECH job training initiatives were established in 2016
- For individuals who are facing socio-economic hardship and have historically faced barriers to employment, including prior incarceration.
- Upon completion of the program, participants earn a CNA certification and are employable at a living wage.
- To date, 101 individuals have earned basic and advanced CNA certification, and 49 graduates are still employed at Broadlawns with a 48.5% retention rate.
- \$250K invested annually to administer these job training programs to assist those from the neighborhoods adjacent to Broadlawns. North Des Moines has the lowest per capita income and highest rate of unemployment in Iowa.
